


Figure 14: What conditions make you feel unsafe while traveling to school? Select all that apply:




Figure 14: What conditions make you feel unsafe while traveling to school? Select all that apply:



Traffic Safety Concerns

Traffic Safety: Student& Family Voices

"The person I'm in the car with drives too fast and sometimes drives too fast to the point that we are going to crash."

-8th Grade Student

"People following me or driving reckless!"

-12th Grade Student

"The traffic and the aggressive drivers are horrific. Little to no regard is given to the crossing guards and or children when crossing the street to get to the school."

"Drivers do not always stop at crosswalks and it feels less safe during after care hours when the crossing guards are not on duty anymore."

Updates: Traffic Safety Legislation

Safe Routes to School Expansion Regulation Amendment Act Signed into law on 1/19/2023 (not included in this year's budget)


What it would do:

- Require traffic signals or all-way stops at every local intersection within 1/4 mile of a school
- Includes mandates for raised cross walks, curb extensions, crosswalk warning pylons, flashing pedestrian signs and speed bumps near schools.
- Expand school safety zones and require automated traffic cameras within school zones.

Community Based Violence / Harassment: Student & Family Voices

"Because there is always a threat walking out of the door anywhere so I always feel a little uneasy."

-11th Grade Student

"...sometimes when im leaving from tutoring I always see this group in the alley looking at me and sometimes I'm scared that they will try to rob me or jump me."

-8th Grade Student

"Fights after school has increased. Individuals [from different schools] have come to the school to fight."

"Things are unpredictable. You don't know when an incident can pop off. I've accepted that I can die at anytime, just don't want it happening in front of my children or for me to witness the same."

Various government agencies coordinated community driven solutions to address student safety.

COMMUNITY DRIVEN:

Local businesses & community-based organizations have agreed to support students and their families.

SCHOOL INVOLVED:

Schools have partnered with communitybased organizations and agencies to ensure student safety.

STUDENT & FAMILY CENTERED:

Students & their families have been a part of creating community driven solutions to address student safety.



Safe Passage is a city-wide, multi-tiered approach to ensure the safety of students & their families while traveling.

What is DC School Connect?

 DC School Connect is a new transportation service for a select number of DCPS & Charter Schools in the Safe Passage Zones in Wards 7 & 8.

How does DC School Connect work?

- Participating schools select 3 shared locations as pickup and drop-off locations for families.
- The DC School Connect shuttles pick up & drop off registered students from the designated locations to and from their school.




Safe Blocks is an initiative where nonprofit organizations with strong relationships in the community hire, train, and deploy Safe Passage Workers.

Enforcement In Schools

Law Enforcement in Schools

School Resource Officers (SRO)

"In an 8-5 vote, the DC Council stuck with a plan to gradually reduce the number of school resource officers in public and charter schools from 60 personnel starting July 1 of this year, to 40 personnel in 2023, then 20 personnel by 2024, ending the program altogether by 2025."

Alternative: Safety Advocate Model

Location: Boulder Valley School District (Colorado)

What is a Safety Advocate?

- Non-uniformed personnel who do not carry guns.
- Assist in conducting investigations, including threat assessments
- Serve as a liaison with the police during emergencies and other events
- They receive anti-bias training
- Work with school staff to support restorative practices within school buildings.

Alternative: Safety Advocate Model

Benefits of Safety Advocates in DC:

- Could remain an MPD funded program;
- Could remove arresting / ticketing powers from officers serving as advocates;
- Removes guns from officers serving as advocates;
- Supports restorative practices in schools;
- Provides professional development opportunities for school staff;
- Builds trust between students, police, and schools;
- Would increase coordination between schools, MPD, MTPD, and CBOs.
